Based in Saratoga Springs, TSA has been providing a broad range of residential treatment services and case management services to individuals in our community for more than 30 years. Today, TSA is staffed by approximately 100 employees, operates 150 residential beds, and provides services to roughly 300 clients in our community. TSA is licensed by the NYS Office of Mental Health, Office of Children and Family Services, and Office of Alcoholism and Substance Abuse Services.
